The validity of Container Train Circular No.07/2017 was for the period of Six months only i.e. upto 31st Dec, 2017.


Now as it is necessary to do so in the public interest, the validity of this container train circular is hereby extended further for a period of One Year from the expiry date i.e. from 1st Jan, 2018 to 31st Dec, 2018 unless modified/cancelled earlier.

A detailed review may further be conducted on Six monthly basis by Zonal Railway about trends of traffic on the said sectors for taking a holistic view and decision in the matter.

All other instructions issued vide letter under above references will continue to hold good.


