

COMMERCIAL CIRCULAR NO.04 OF 2018
DRAFT NOTIFICATION FOR TRC NO.01 OF 2018
(Coaching)

Sub: Levy of Mela Surcharge during **Annual convention of Bible Mission** of Guntur Division to be held from **27.01.2018 to 29.01.2018**.

Authority: Sr.DCM/GNT letter No.GNT/C.272/Genl dated 02.01.2018.

Annual convention of Bible Mission will be held at Nagarjun Nagar of Guntur Division from 27.01.2018 to 29.01.2018. Special arrangements have been made at **Mangalagiri** and **Nambur** Railway stations for dealing with the additional passenger traffic expected during **Annual convention of Bible Mission**.

As per the instructions given by Railway Board vide letter No.TCII/2067/06/Mela surcharge dated 24.03.2017, (Board Commercial Circular No.24 of 2017) and this office Commercial Circular No.125 of 2017, dated 06.04.2017) Mela surcharges are to be levied at the following rates for both Reserved and Un-Reserved tickets.

S.No	Class	Rate per passenger
01	Second Class (Ordinary & Mail/Exp)	5
02	Sleeper Class (Ordinary & Mail/ Exp)	10
03	AC Chair Car /AC 3-Tier	20
04	First Class(Ord/ Mail/Exp) & AC 2-Tier	30
05	First AC Class	40

This surcharge is to be levied only in case the basic fare of one ticket is more than Rs. 15/- (and not on those tickets whose basic fare is upto Rs.15/-). in connection with **Annual convention of Bible Mission from 27.01.2018 to 29.01.2018**.

Mela surcharge will be levied at **Mangalagiri** and **Nambur** stations for tickets with journeys commencing during Mela days i.e. **from 27.01.2018 to 29.01.2018**. This surcharge will not be levied on single journey tickets issued from other stations on Indian Railways for journeys terminating at Mela stations. Mela surcharge is levied on all tickets issued from Mela stations and also on return tickets issued to the Mela station and back.

In case of reserved tickets already issued without inclusion of Mela surcharge, it should be ensured that difference is recovered either by TTEs on the trains or by the Booking/Reservation offices before commencement of the journey by passengers. Commercial Inspectors and TIAs should visit all the important stations and ensure collection of difference of fare.


No part of Mela surcharge is reimbursed to the State Government/ Municipalities

All other terms and conditions regarding levy of Mela surcharge will remain the same.

Dy. CCM/PRS to make necessary changes in PRS and UTS in consultation with CRIS.

All staff to note and act accordingly.
