Sub: Reduction in carrying capacity of SLRD coaches.
Ref: This office Commercial Circular Letter No.147 of 2016

(Board's Freight Marketing Circular No. 15 of 2018)

Attention is invited to this office Commercial Circular No. 147 of 2016 (Board's Freight Marketing Circular No. 9 of 2016) wherein instructions were issued in regard to enhancement of carrying capacity of SLRD coaches to 05 tonnes in each LC (Total 10 tonne in SLRD coach).

However, the issue of enhancement of loading capacity of SLRD coaches has been examined by the Mechanical (Coaching) Directorate of Railway Board in consultation with RDSO, and it has been decided to reduce the parcel carrying capacity of each compartment of SLRD coaches from the existing 05 tonne to 04 tonne.


Henceforth, the permissible carrying capacity of each compartment of SLRD coaches shall be 04 tonne. Thus, the total permissible carrying capacity of both the compartments of SLRD coach shall be 08 tonne.

This issues with concurrence of Finance Directorate of Ministry of Railways.

The above mentioned instruction shall come into force with immediate effect.

Note and notify all concerned accordingly and ensure strict compliance.
