**Sub: Modification of Carrying Capacity over JPTN – VNUP section of
S.C.Railway.**


Vide, this office Commercial Circular no.109 of 2018 dated 17.05.2018, it was advised that Jaggayyapeta Town – Janpahad Section over SC Division and Janpahad to Vishnupuram Section over Guntur Division will be charged under CC+6+2 route for the rakes loaded from 00.00 hours of 19-05-2018.

Now, the competent authority has decided to withdraw the Commercial Circular no.109 of 2018 with immediate effect.

Hence, the charging of freight between Jaggayyapeta Town and Vishnupuram stations will be continued with the existing CC+8+2 as incorporated in RBS, till further advice.


