Sub:- Introduction of Engine on Load (EOL) Scheme between South

1. M/s.Krishnapatnam Port Company Limited (PKPK) siding served by Krishnapatnam Railway Station on Vijayawada Division of South Central Railway was notified for handling both outward and inward goods traffic vide this office Commercial Circular No.172 of 2009 dated 03.07.2009.
2. M/s. Krishnapatnam Port Company Limited (PKPK) siding authority has requested for implementation of Engine-On-Load Scheme (EOL) at M/s.Krishnapatnam Port Company Limited (PKPK) siding.
3. The competent authority has examined the issue and decided to permit Engine on Load (EOL) Scheme at M/s.Krishnapatnam Port Company Limited (PKPK) siding served by Krishnapatnam Railway Station on Vijayawada Division for a period of one year with effect from 1<sup>st</sup> June 2018 and valid up to 31<sup>st</sup> May 2019, in accordance with terms and conditions laid down vide Freight Marketing Circular No.05 of 2013 dated 07.03.2013 and that of EOL agreement executed between South Central Railway and Krishnapatnam Port Company Limited.
4. **These instructions will come into effect from 01.06.2018 (i.e. from first June two thousand eighteen) and will remain in force for a period up to 31<sup>st</sup> May 2019.**
