

COMMERCIAL CIRCULAR No.13 OF 2018
DRAFT NOTIFICATION FOR TRC NO.01 OF 2018
(Coaching)

Sub: Fare structure of AC EMU

Authority: Railway Board's Ir No.TC-II/2910/17/AC EMU dated
22.12.2017 (Board's Commercial Circular No.85 of 2017).


1. Ministry of Railways has decided to introduce Air Conditioned (AC) EMU service over Indian Railways.
2. The fare structure of AC EMU service shall be as under:
 - 2.1. Base fare of the single journey of AC EMU shall be 1.3 times of the base fare of existing Fare of single journey tickets for First class tickets. However, as an introductory offer for a period of initial six months, the base fare of single journey of AC EMU shall be charged 1.2 times of the base fare of existing Fare of single journey tickets for First class tickets. The difference between 1.3 times and 1.2 times will be shown in the ticket as discount during the introductory period.
 - 2.2. Season tickets Weekly, Fortnightly and Monthly seasons tickets shall be charged equivalent to 5, 7.5 and 10 single journeys of AC EMU respectively. No other type of season tickets shall be issued for the time being.
 - 2.3. Other supplementary charges.
 - (i). MUTP surcharge or any other charges if applicable shall be levied separately as per applicable rate for first class coach.
 - (ii). Goods and Service Tax (GST) @ 5% shall be levied on the total fare as per the existing principle.
3. Other conditions.
 - (i). AC EMU ticket holder shall also be allowed to travel by first class compartment of local trains.
 - (ii). Announcement shall be made as more trains are introduced, the regular fare shall be 1.3 times of the basic fare of First class single journey tickets and other applicable supplementary charges.
 - (iii). All other terms and conditions for issue of journey tickets/season tickets shall be same.
4. CRIS is requested to make necessary changes in the software.


