Sub: Haulage charges recoverable for movement of Milk traffic in Railway Milk Tankers (RMT) owned by private parties.

Attention is invited to this office Commercial Circular No. 72 of 2018 (Board's Freight Marketing Circular No. 7 of 2018) notifying the Haulage charges recoverable for movement of Milk traffic in Railway Milk Tankers (RMT) owned by private parties. These charges were effective from 01.07.2018 to 30.06.2019.


In order to promote milk traffic, Ministry of Railways have decided, as a special case, not to increase the haulage rates for movement of Milk traffic for the period from 01.07.2019 to 30.06.2020. Accordingly, the haulage charges for movement of Milk traffic for the period from 01.07.2019 to 30.06.2020 shall remain the same as per the haulage charges applicable for the period from 01.07.2018 to 30.06.2019, notified vide this office Commercial Circular No.72 of 2018 dated 28.03.2018.

There is no change in other terms and conditions.

This issues with the concurrence of Finance Directorate of the Ministry of Railways.

Note and notify all concerned accordingly and ensure strict compliance.
