The new BG line between Obulavaripalli to Venkatachalam Road Junction station a new BG line on Vijayawada Division of South Central Railway is now opened for **Goods traffic "from 03-07-2019"**.

The Chargeable distances between Obulavaripalli to Venkatachalam stations have already been notified vide Commercial Circular No.24 of 2019 dated 18.02-2019. These distances have been incorporated in the RBS. Hence, the charges have to be levied as per these notified distances, **with effect from 03-07-2019**
