DRAFT NOTIFICATION FOR TRC NO. 07 OF 2019
(Coaching)

Sub: Revision of freight charges for transportation of all animals including Wild animals & Birds in Parcel vans and Brake vans.

Authority: DFM/Railway Board's Lr No.TC-II/2080/12/Live Stock dated 24.07.2019.(Freight Marketing Circular No.20 of 2019).

Vide Freight Marketing Circular No.07 of 2016 dated 27.06.2016, charges for transportation of all animals including wild animals & birds in Parcel-vans and Brake-Vans were revised w.e.f. 15.07.2016, from Scale-'L'+ 25% to 'L' Scale irrespective of the category of trains. The revised charges were initially applicable up to 30.03.2017 and after review further extended from time to time, last being up to 30.06.2019 vide FM Circular No.32 of 2018 dated. 31.12.2018/01.01.2019 (this office Commercial Circular No.01 of 2019).

2. The matter has been reviewed and the Ministry of Railways have now decided that the charges for transportation of all animals, including wild animals & birds, in parcel-vans and Brake-vans shall henceforth be at Scale-'L'+25% instead of at 'L'-Scale.
3. No Free allowance shall be permissible in case of booking of animals/birds as luggage.
4. Apart from above other charges like development charges, GST etc shall be levied separately as per the instructions notified from time to time.
5. Other terms and conditions for booking of animals including wild animals/birds will remain the same.
6. This issues with the Concurrence of the Finance Directorate of the Ministry of Railways.
7. Necessary instructions may be issued to all concerned immediately.

"Staff in the field units should read the instructions carefully and understand the same, thoroughly. Thereafter, the instructions should be implemented. In case of any doubts, letters may be addressed to the respective Sr.DCMs with copy to PCCM's Office."


