1. In continuation to above instructions, Railway Board has directed that the validity of Photo Identity Cards issued by Railways to Accredited Press Correspondents shall be co-terminus with the validity certificate issued by Press information Bureau / Other Competent State & Local authorities.
2. Necessary instructions may be issued to all concerned immediately including PRS/UTS immediately and compliance ensured.
3. Wide publicity through various media may be given. **Divisions are advised to intimate the concerned accreditation certificate issuing agencies within their jurisdiction regarding the revalidation procedure.**
