DRAFT NOTIFICATION FOR TRC NO.06 OF 2018
(Coaching)

Sub: Running of Charter Saloons as 25th coach in passenger carrying trains running with 24 coaches.

2. GGM/Coordination (T&IT), IRCTC's letter no. 2017/IRCTC/Tourism/Salon Cars dated 16.05.2018.

Authority: Railway Board's Letter No.2017/Coaching/33/13 Pt. A dated 05.06.2018 (Board's Coaching Circular No.110 of 2018).

1. In terms of letter under reference (1) above, attachment of an Inspection Carriage as 25th coach is permitted in case of trains running with 24 coaches.
2. Vide letter under reference (2) above, IRCTC has requested Board to consider and permit attachment of Charter Saloons as 25th Coach in trains running with 24 coaches, on par with Inspection Carriages.
3. The aforesaid request of IRCTC has been considered in Board's office and it has been decided to permit attachment of Charter Saloons on Full Tariff Rates (FTR) as 25th coach in trains running with 24 coaches (except in prohibited trains) and subject to the condition of availability of platform of suitable length.
