Sub: Restoration of Concession on the certificate to be issued by Shootingball Federation of India and Tennis Ball Cricket Federation of India..

Ref: Railway Board's Commercial Circular No.14 of 2018 dated 06.03.2019 and (this office Commercial Circular No.63 of 2018)

Authority: Railway Board's Ir No.TC-II/2035/11/Sports/Policy/1 (Board's Commercial Circular No.37 of 2019) dated 07.08.2019

In partial modification to Railway Board's Commercial Circular No 14 of 2019 dated (6.03.2019) (this office Commercial Circular No. 63 of 2019), Ministry of Railways desire that since the suspension of the following sports federations have been revoked by the Department of Sports, Ministry of Youth Affairs & Sports, therefore, concession in passenger fare as per Rule should be granted on the certificate issued by the following sports federations for their respective sports persons with immediate effect.

S. No.	Name of Sport Federation
1.	Tennis Ball Cricket Federation of India, Gorakhpur, Uttar Pradesh
2.	Shootingball Federation of India, Campus, S.D. Public School, Raj Nagar Extension, Ghaziabad, Uttar Pradesh.

Accordingly, authority given to Secretary, Sports Authority of India or Executive Director (Teams) from Sports Authority of India Should be treated as withdrawn for these two Sports disciplines.

There is no other change in the rule and other terms and conditions.
Necessary instructions may be issued to all concerned immediately.
Ensure action accordingly.
