

COMMERCIAL CIRCULAR LETTER No.175 OF 2018

Sub: Amendment No.2 to Freight Marketing Circular No.11 of 2016-Policy Circular on Private Sidings.

- 1.0 The Policy on Private Siding was issued vide Freight Marketing Circular No.11 of 2016 under Board's letter No.99/TC(FM)/26/1/Pt-II dated 22.08.2016 and this office vide Commercial Circular No.179 of 2016 dated 12.09.2016.
- 2.0 Vide Railway Board's letter cited under reference above dated 14.06.2018, It has been decided to amend Para 9 (a) (iii) of "Annexure-3" of the aforesaid circular as under:


Para 9 (a) (iii) of "Annexure-3" of Freight Marketing Circular No.11 of 2016.

Whenever the weigh-bridge goes out of order, it shall be put right by the siding owner at his/ her own cost within 3 (three) days, failing which a penalty of Rs.4000/- per day or part thereof for the next 10 (ten) days, and Rs.8000/- per day thereafter shall be imposed.

- 3.0 Commercial Circular No. 148 of 2018 dated 21.06.2018 was issued to this effect.
- 4.0 **Now, it has been decided that the above amendment to Para 9 (a) (iii) will be applicable to all the private weighbridges on South Central Railway.**

Staff in the field units should read the instructions carefully and understand the same, thoroughly. Thereafter, the instructions should be implemented. In case of any doubts, letter may be addressed to the respective Sr.DCM with copy to PCCM's office to note and act accordingly.
