

**COMMERCIAL CIRCULAR No.177 2018
DRAFT NOTIFICATION FOR TRC NO. 07 OF 2018
(Coaching)**

Sub: Booking of FTR trains/coaches online through single window booking system by IRCTC.

Ref: Railway Board's Commercial Circular No.08 of 2018 dated 05.02.2018, Commercial circular No.14 of 2018 dated 15.02.2018 & Commercial Circular No 26 of 2018 dated 07.05.2018 & Commercial Circular No.28 of 2018 dated 16.5.2018 and letter of even no. dated 06.06.2018 (this office Commercial Circular No.28 of 2018 dated 14.02.2018, 111 of 2018 dated 22.02.2018, 112 of 2018 dated 17.5.2018 & 113 of 2018 dated 17.05.2018 & 136 of 2018).

Authority: Railway Board's Ir No.TC-II/2033/2006/Policy/2 dated 05.07.2018. (Commercial Circular No. 36 Of 2018)

Further to the instructions issued vide this Office Commercial Circulars (Board's Commercial Circulars) and letter referred to above, Ministry of Railways have further decided that, as a special case in relaxation of the Rule, instructions on booking of special trains/coaches on Full Tariff Rates (FTR) through IRCTC single window booking system shall not be applicable on the coaches/trains on FTR booked by Central Armed Police Forces (CAPFs) and Defence Forces.

2. Accordingly, booking of trains/ coaches on FTR by Central Armed Police Forces (CAPFs) and Defence Forces shall continue to be booked as per the earlier applicable manual procedure and the terms and conditions in vogue prior to implementation of the online booking system w.e.f 18.05.2018.

3. The above should be implemented with immediate effect.

4. Necessary instructions may be issued to all concerned immediately.

"Staff in the field units should read the instructions carefully and understand the same, thoroughly. Thereafter, the instructions should be implemented. In case of any doubts, letters may be addressed to the respective Sr.DCMs with copy to CCM's Office."
