

**COMMERCIAL CIRCULAR No.181 2018**  
**DRAFT NOTIFICATION FOR TRC NO. 07 OF 2018**  
**(Coaching)**

Sub: Booking of FTR trains/coaches online through single window booking system by IRCTC.

**Authority:** Railway Board's Ir No.TC-II/2033/2006/Policy/2 dated 17.07.2018.

Northern Railway has sought clarification as to whether the request for FTR coaches registered on Zonal Railways prior to 17.05.2018 are to be dealt on previous pattern. The matter has been examined by Board and clarified that since the booking of FTR trains/coaches/saloons has been made online through single window booking system by IRCTC w.e.f.18.05.2018, the requests for FTR trains/coaches already registered prior to the implementation of this scheme shall be permitted to be processed further by the Zonal Railways as per the practice in vogue prior to 18.05.2018 and priority already assigned to such requests shall be maintained. However, it is reiterated that any request received by the Zonal Railways after the midnight of 17.05.2018, excepting those received from Central Armed Police Forces (CAPFs) and Defence Forces, shall only be booked through single window booking system by IRCTC.

2. Vide this office Commercial Circular No. 177 Of 2018 dated 16.07.2018. (Board's Commercial Circular No. 36 of 2018 dated 05.07.2018.) booking of trains/coaches on FTR by Central Armed Police Forces (CAPFs) and Defence Forces has been permitted as per the earlier applicable manual procedure and the terms and conditions in vogue prior to implementation of the online booking system w.e.f. 18.05.2018.


