Sub: - Extension of Guidelines regarding transportation of relief material to Flood affected state of Kerala

Ref: - 1) Railway Board letter of No. TCR/1147/2018/1 dt 18.08.18, 20.08.18 & 29.08.18

2) This office Commercial Circular No.195 & 194 of 2018.

1.0 Ministry of Railway, vide above referred letters, had issued guidelines regarding transportation of relief material to flood affected state of Kerala, which are effective up to 31-08-2018.


2.0 In continuation to above referred letters, Indian Railway has now decided to extend the validity of above referred letters up to 15 September,2018, or till further orders, whichever is earlier.

Rest of the guidelines shall remain unchanged.

This issues with approval of Traffic Transportation and Finance directorate of Ministry of Railway.


