The procedure to be followed for accountal of free time for rakes in M/s Krishnapatnam Port Company Limited siding (PKPK) has been notified vide Commercial Circular No.210 of 2018 dated 17-09-2018. It was advised that these instructions will come into effect from 00:00 hours of 20-09-2018 and the new procedure will start applying for rakes leaving KAPT after 00:00 hours of 20-09-2018.
2. **Now, it has been decided by the Competent Authority that the Commercial Circular No.210 of 2018 dated 17-09-2018 should be treated as withdrawn and instructions issued vide Commercial Circular No.116 of 2018 dated 23-05-2018 should be followed.**
3. **The Commercial Circular No. 210 of 2018 will be applicable for the period between 00:00 hours of 20-09-2018 to 00:00 hours of 25-09-2018.**
4. Note and notify all concerned accordingly and ensure strict compliance
