The issue of chargeable tariff for Defence Units for booking of single coach when attached with general Mail/Express/Passenger trains has been examined by Board and it is advised that the extant rules/instructions on booking of special coach on Full Tariff Rates shall be applicable.

"Staff in the field units should read the instructions carefully and understand the same, thoroughly. Thereafter, the instructions should be implemented. In case of any doubts, letters may be addressed to the respective Sr.DCMs with copy to PCCM's Office."
