Sub: Permission granted to M/s CONCOR to Co-use M/s The India Cements Ltd siding served by Vishnupuram (ICLV) station for goods traffic.

Permission is hereby granted by the competent authority to M/s CONCOR to Co-use the private siding of M/s The India Cements Ltd siding (ICLV) served by Vishnupuram Railway station on Guntur Division of South Central Railway for a period of six months **with effect from 06-02-2018 to 05-08-2018.**

The "Co-user" Shall be governed by the same rules and regulations of Railways as applicable under the private siding agreement of ICLV for booking and delivery of traffic for levy of freight and other charges concerned.

The "Co-user" shall be responsible for all payments of Railway dues that may accrue for availing this facility and in case of default; the siding owner will be responsible for payment of dues as per terms and conditions of clause 15 of private siding agreement

Freight, Haulage, siding, shunting and all other charges as due should be levied as per rules and instructions in force from time to time.

This permission is given **with effect from 06-02-2018 and valid up to 05-08-2018.**
