The Co-use permission was granted to M/s.CONCOR to co-use M/s. The India Cements Ltd., (ICLV) siding served by Vishnupuram Railway station on Guntur Division of South Central Railway for a period of six months from 06.02.2018 to 05.08.2018 was notified vide this office commercial circular No.23 of 2018.

Further, on the request of M/s.CONCOR and on the no-objection from M/s. The India Cements Ltd., (ICLV) siding served by Vishnupuram station the Co-use permission is granted by the competent authority in favour of M/s CONCOR to Co-use M/s. The India Cements Ltd., (ICLV) siding served by Vishnupuram station on Guntur Division of South Central Railway for a period of six months **with effect from 06.11.2018 to 05.05.2019.**

The co-user shall be governed by the same rules and regulations of Railways as applicable under the private siding agreement of ICLV for booking and delivery of traffic for levy of freight and other charges concerned.

The co-user shall be responsible for all payments of Railway dues that may accrue for availing this facility and in case of default, the siding owner will be responsible for payment of dues as per terms and conditions of clause 15 of Private Siding Agreement.

Freight, haulage, Siding, Shunting and all other charges as due should be levied as per extant rules and instructions in force from time to time.

The Co-User permission is given **with effect from 06.11.2018 and valid up to 05.05.2019**
