Sub: Inclusion of M/s. ANAND CARBO PRIVATE LIMITED as authorized user of Greenfield PFT of M/s. Vimla Infrastructure (India) Pvt. Ltd (VIPN) served by Narasingapalli station.

1. With effect from 10-3-2017, the Greenfield PFT for M/s. Vimla Infrastructure Pvt. Ltd., served by Narasingapalli Railway Station was opened for handling all traffic except "C" priority Coal and Coke. However, outward loading of Coal and Coke under "D" priority is allowed. This PFT is not opened to handle POL traffic. This was notified vide this office Commercial Circular No.82 of 2017.
