Sub: Permission granted to M/s.CONCOR to co-use M/s. Bharathi Cement Corporation Private Limited (MBCY) siding served by Yerraguntla Railway station.

On the request of M/s.CONCOR & based on the no-objection from M/s. Bharathi Cement Corporation Pvt Ltd (MBCY) siding served by Yerraguntla Railway station, the Co-use permission is granted by the competent authority in favour of M/s CONCOR to Co-use M/s. Bharathi Cement Corporation Pvt Ltd (MBCY) siding served by Yerraguntla Railway station for loading BULK CEMENT IN JUMBO BAGS only in Containers on Guntakal Division of South Central Railway for a period of three (3) years with effect from 20-12-2018. i.e. **up to 19-12-2021.**

The co-user shall be governed by the same rules and regulations of Railways as applicable under the private siding agreement of MBCY for booking and delivery of traffic for levy of freight and other charges concerned.


The co-user shall be responsible for all payments of Railway dues that may accrue for availing this facility and in case of default, the siding owner will be responsible for payment of dues as per terms and conditions of clause 15 of Private Siding Agreement.

Freight, haulage, Siding, Shunting and all other charges as due should be levied as per extant rules and instructions in force from time to time.

The Co-User permission is given for loading BULK CEMENT IN JUMBO BAGS only in Containers **with effect from 20-12-2018 and valid up to 19-12-2021.**
