

**COMMERCIAL CIRCULAR No. 29 OF 2018**

Sub: Grant of STS discount for De-Oiled Rice Bran (DORB) traffic on monthly basis in favour of M/s. Merchant Agri Global Pvt. Ltd., for loading from Warangal Goodshed on Secunderabad division of South Central Railway.

1. General Manager has accorded approval for grant of Station to Station (STS) rates discount @ 16% on NTR on De-Oiled Rice Bran (DORB) traffic in favour of M/s. Merchant Agri Global Pvt. Ltd., for loading from Warangal Goodshed on Secunderabad Division. The STS concession will be on monthly basis starting from February 2018 to January 2019.
2. An Agreement was executed between SC division and M/s. Merchant Agri Global Pvt. Ltd., on 31-01-2018 for grant of STS discount @ 16% for the period February 2018 to January 2019. The STS discount will be on monthly basis starting from February 2018 onwards and for a period of one year i.e., from February 2018 to January 2019.
3. The terms and conditions as embodied in the agreement dated 31<sup>st</sup> January 2018 and the policy guidelines issued from Railway Board from time to time shall continue to be operative and in force between two parties and the STS concession will be administered as per the terms and conditions of the Agreement.
