1. Please refer to Corrigendum No.8 to Rates Master Circular/FIS/2015/0 (this office Commercial Circular No.223 of 2018 dated 11.10.2018) vide which Private Freight Terminals were included in the Permitted Terminals for Incentive Scheme for Freight Forwarders.
2. The matter has been reviewed, by the competent authority and it has been decided to extend the validity of the inclusion of Private Freight Terminals (PFTs) for Incentive Scheme for Freight Forwarders beyond 27.03.2019 **for a further period up to 31.03.2020**
3. All other terms and conditions mentioned in Rates Master Circular/FIS/2015/0 shall remain unchanged.
4. Periodic Review may be undertaken and feedback be apprised to Board's office for further evaluation of the scheme.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
