DRAFT NOTIFICATION FOR TRC No. 04 OF 2018
(Goods)

Sub:- Notifying M/s Lakshmi Venkateshwara Infra Logistics Pvt. Ltd., served by Kaukuntla Railway station of Hyderabad Division to handle Outward traffic also..

Ref:- This Office Commercial Circular No. 185 of 2017.

1. With effect from 20-06-2017 a new Greenfield Private Freight Terminal (PFT) in favour of M/s.Lakshmi Venkateshwara Infra Logistics Pvt. Ltd., served by Kaukuntla Railway station on SC-DHNE section of Hyderabad Division on South Central Railway was notified to handle **"only Inward Goods Traffic"** i.e., all inward traffic excluding coal and coke under "C" priority vide Commercial Circular No. 185 of 2017. This PFT is not notified for POL traffic.
2. Now, it has been decided by the competent authority to notify the above PFT to handle all Outward goods traffic also except Coal, Coke under "C" priority. However, outward loading of Coal and Coke under "D" priority is allowed. This PFT is not opened for POL traffic.
3. All other terms and conditions of Freight Marketing/Master Circular/PFT/2015/0 dated 02-01-2015 and corrigenda there to and that of agreement executed by M/s. Lakshmi Venkateshwara Infra Logistics Pvt. Ltd., with South Central Railway shall be strictly adhered to.
4. Staff in the field units should read the above instructions carefully and understand the same, thoroughly. Thereafter, the instructions should be implemented. In case of any doubts, letter may be addressed to the respective Sr.DCMs with copy to CCM's office.
