DRAFT NOTIFICATION FOR TRC No. 03 OF 2018

Sub: Haulage charges recoverable for movement of Milk traffic in Railway Milk Tankers (RMT) owned by private parties.

Ref: Railway Board Freight Marketing Circular No. 07 of 2018 issued vide letter No. TC-II/2642/2002/Milk dated 14.03.2018.

Ministry of Railways has decided to increase the haulage rates for movement of Milk Traffic with effect from 01.07.2018 to 30.06.2019, are as under :

| a) | Haulage charges of loaded RMT | Rs.87 per vehicle KM (For 8 wheeler Milk Tanker) |
| b) | Empty RMTs for change of base or for POH | Rs.43.50 per vehicle KM (For 8 wheeler Milk Tanker) |


No charges are leviable for empty movements of RMTs from unloading points to the loading points for re-loading.
