CPTM/SC vide letter under reference has notified the following Trains to be diverted via Rayanapadu (RYP) station duly by-passing Vijayawada (BZA) station w.e.f 13.04.2019:

- a. Train No. 12737/38-COA-LPI-COA Gowthami express
- b. Train No. 12775/76-CCT-LPI-CCT Kokanada express
- c. Train No. 20809/10-SBP-NED-SBP (weekly thrice)
- d. Train No. 20811/12-VSKP-NED-VSKP (weekly thrice).

All the above mentioned trains have been provided 5 minutes or more stoppage time at RYP station. In addition to the above trains, holiday specials, Summer specials trains are also diverted via RYP duly by-passing BZA station. In future, many more trains are likely to be diverted via RYP station by-passing BZA station.

Hence, The Competent Authority has decided to open Rayanapadu station of BZA Division for handling all types of Parcels and Luggage Traffic w.e.f **13.04.2019**.
